

Top 10: Need-to-Know Legal Points

WOW COMMODITY PURCHASE PROGRAM®

1. WOW Logistics is agreeing to purchase a commodity from either the counterparty or the manufacturer/supplier and hold it in the Commodity Purchase Program until the counterparty is ready to purchase it.
2. The counterparty is agreeing to purchase the commodity from WOW Logistics, regardless of the quality of the commodity, market conditions, or any other factor. The counterparty's obligation to repurchase the commodity from WOW Logistics is irrevocable, absolute and cannot be terminated, waived or assigned.
3. WOW Logistics' essential duties with respect to the Commodity Purchase Program are to:
 - Purchase the commodity from the counterparty or manufacturer/supplier;
 - Hold the commodity according to the commodity specifications provided to WOW Logistics by the counterparty;
 - Transfer the commodity to the counterparty when the counterparty so directs, but not later than the shelf life, if applicable, of the commodity.
4. Counterparty's essential duties with respect to the Commodity Purchase Program are to:
 - Transfer good and unencumbered title of the commodity to WOW Logistics upon purchase;
 - Establish the specifications for the commodity and verify those specifications are satisfied;
 - Purchase the commodity from WOW Logistics and pay all Commodity Purchase Program fees and charges.
5. While WOW Logistics holds the title to the commodity, WOW Logistics insures the commodity against certain types of losses caused by natural disasters, such as fire and storm.
6. There are two types of fees associated with the Commodity Purchase Program:
 - A time-based fee that is calculated much like simple interest and is based upon the cost of the commodity and the initial and ongoing holding, moving, and shipping of the commodity (when applicable).
 - Holding (aka storing) and moving (aka handling) fees.
7. The counterparty retains an exclusive right to purchase the commodity held within the Commodity Purchase Program. Provided that there is no default by counterparty, WOW Logistics has no right to sell the commodity to anybody but the counterparty.
8. If in the event the Commodity Purchase Agreement entered into between WOW Logistics and the counterparty is determined to be an agreement intended for security rather than an agreement for the purchase and sale of goods, the counterparty agrees to grant WOW Logistics a first priority security interest in the commodity. Such security interest shall be automatically terminated and released when title to the commodity is being transferred to the counterparty.



9. The counterparty will have access to the commodity while being held in the Commodity Purchase Program to perform inspections related to the quality of the commodity and/or to determine whether the commodity is in compliance with certain specifications. At no time will WOW Logistics be responsible for inspecting the commodity for purposes of quality and/or conformance with specifications.
10. The interest rate used in the time-based fee may adjust monthly, coinciding with adjustments to the rate of WOW Logistics credit facility. The rate is based upon the 30-day LIBOR rate.

The Commodity Purchase Agreement supersedes all prior oral or written statements, including this Top 10 Need –To-Know Legal Points document.
